# LA VENDÉE ARCTIQUE LES SABLES D'OLONNE

## RULES AND REGULATIONS

### Art 1 : General

These terms and conditions are binding on everyone and must be strictly applied. No derogations from the present terms and conditions will be allowed unless special written conventions are concluded by the parties and expressly approved by the SAEM Vendée. The present general rules replace any clause to the contrary and notably terms and conditions of the "Client" to which the latter formerly waives his right to use.

### Art 2 : Conditions for participation

Companies who wish to reserve some space or a service must supply the SAEM Vendée with the order form, serving as application for participation, completed and signed as well as 100% of the total amount of costs of participation in the project, all taxes included, as well as the completed information form. The application for participation will be done through the official form, called order form : "public relations", prepared by the SAEM Vendée and duly completed and signed. An incomplete file sent shall not be taken into consideration and can justify the automatic rejection of the request. In sending the documents requested above, the client implies acceptance full and whole of these conditions. The SAEM Vendée reserves its right to validate the reservation of the client - subject to space availability - with regards specifically to the suitability of the services presented and the nature of the operation planned with the requirements in terms of homogeneity, balance, security and image of the Village of the Vendée Arctique - Les Sables d'Olonne. The SAEM Vendée is under no obligation to justify its decision. In such event, the full payment shall be returned by the SAEM Vendée. In sending the invoice corresponding to the reservation, the SAEM Vendée validates the reservation. Eligibility of the company by the SAEM then becomes firm and final.

### Art 3 : Participation fees

Rental fees for the different spaces and additional services are set by the SAEM Vendée and are listed on the order form attached. Fees included in the order form are applicable to all companies, regardless of their nature and their space.

### Art 4 : Security

General monitoring is provided by the guards of the Village who are solely in charge of securing the sector entrusted to their care by the SAEM Vendée. Active monitoring will be carried out outside opening hours, but the client is responsible for monitoring of its space during opening hours to the public. Consequently, the client waives any recourse against the SAEM Vendée in the event of damage observed and suffered.

### Art 5 : Cancellation

If the client notifies the SAEM Vendée of the cancellation of its participation before 2nd May 2022, he will be charged only 50% of the total amount due in regards to his reservation as compensation for damages. Beyond 2nd May 2022, the total amount paid shall be retained by the SAEM Vendée. Cancellation must be notified by registered mail to the SAEM Vendée, otherwise it will not be taken into consideration. Furthermore, the SAEM Vendée could be forced to close up the Village to the public or cancel the event in particular for reasons of public interest and public order. Situations justifying closing up the Village partially or completely are : any weather, sanitary, economic, political or social situation, locally, domestically or internationally, that would prevent conducting the event or entail risks of unrest and disorder seriously affecting the organization and running of the event. In this case, it is reminded that the SAEM Vendée shall not be held responsible for damage suffered in

connection with the closing or cancellation. In such event, the SAEM Vendée will reimburse the client for the amount paid prorated to the number of closed days. By 16<sup>th</sup> May 2022, if the skipper representing the client has not been selected to participate in the Vendée Arctique - Les Sables d'Olonne, the total amount of sums paid will be reimbursed.

### Art 6 : Damage of the space

Any damage caused to the building, installations, floors, furniture or objects supplied by the SAEM Vendée, will be evaluated by the organizer and paid for by the client responsible for this damage.

### Art 7 : Application of rules

The SAEM Vendée has the right to rule in any situation not covered in the present rules and to amend them or add others, if necessary, with immediate effect. Circulars provided later will be an integral part of the present rules. Any infringement of these rules can result in the expulsion of the offending client if the SAEM Vendée decides it, even without formal notice and without reimbursement of participation fees or any other sum paid which will remain vested in the SAEM Vendée. The SAEM Vendée shall use the vacant space in any way it wishes.

### Art 8 : Competent courts

In signing their order form, clients declare unconditional acceptance of the terms of the present rules for which only the text in French language has legal value. In the event of a dispute, and prior to any proceedings, the client undertakes to submit his statement to the SAEM Vendée. In case of disagreement, the courts of the place of performance of the contract will be solely competent, even in the event of appeal or multiple defendants.

### Art 9 : Use of the logo

The logo of the race is property of the SAEM Vendée. Its use is strictly regulated.
